**AMENDMENT OF CERTIFICATION**

Pursuant to Section 2422.1 of the Regulations of the Federal Labor Relations Authority, a petition was filed seeking to amend the recognition granted to the National Association of

Government Employees(NAGE), Local R5-168, AFL-CIO, as the exclusive representative of a consolidated unit of certain employees employed at Fort Polk, Louisiana, as Consolidated on July 26, 2004, in Case No. DA-RP-04-0017. NAGE Local R5-168 petitions to change the designation of the exclusive representative for the existing bargaining unit, from the National Association of Government Employees, Local R5-168, AFL-CIO to the National Association of Independent Labor (NAIL).

On June 20, 2006, I issued a Decision and Order finding that the recognition may be amended as requested. No application for review of my Decision and Order has been filed.

Pursuant to the authority vested in me as Regional Director,

**I ORDER** that the recognition granted to the National Association of Government Employees, Local R5-168. AFL-CIO, as the exclusive representative of the following consolidated unit of employees:

Group No. 1

Included: All non-supervisory wage grade and general schedule employees of the U.S. Department of the Army, Headquarters, Joint Readiness Training Center, Fort Polk, Louisiana.

Excluded: All professional employees, management officials, supervisors, employees of the Post Fire Department, temporary employees with appointments not to exceed 90 days, guards, and employees described in 5 U.S.C. § 7112(b)(2), (3), (4), (6), and (7).

Group No. 2

Included: All non-supervisory wage grade and general schedule employees of the U.S. Department of the Army, U.S. Army Installation Management Agency, Fort Polk, Louisiana.


Excluded: All professional employees, management officials, supervisors, employees of the Post Fire Department, temporary employees with appointments not to exceed 90 days, guards, and employees described in 5 U.S.C. § 7112(b)(2), (3), (4), (6), and (7).

Group No. 3

Excluded: All professional employees, management officials, supervisors, employees of the Post Fire Department, temporary employees with appointments not to exceed 90 days, guards, and employees described in 5 U.S.C. § 7112(b)(2), (3), (4), (6), and (7).
